- IGA memberships are valid 3/1/18 through 2/28/19.
- IGA memberships are not transferable.
- All IGA members are required to register in the Golf Shop prior to teeing off.
- Daily receipts must be shown to the starter for our staff to properly track rounds of golf.
- As a daily-fee course, there will be dates in which tournament groups will take up the course. Due to this, there will be some dates where tee times will not be available to you as an IGA member.
- 15% off merchandise discounts apply to full-priced soft goods. This discount is not valid towards hard good sales (equipment, special orders), or towards any sale item that is already discounted 10% or more.
- Prizes will be awarded through Pro Shop Credit. These credits may be used for merchandise in the golf shop only.
- IGA members are eligible to receive complimentary practice balls the day of IGA events. Additional practice balls must be purchased at normal rates.
- IGA membership fees are non-refundable – in the event of a medical emergency or relocation out of the area, exceptions may be made by the GM on a case-by-case basis.
