- Based on course availability, unlimited golf including cart (depending on type of Pass purchased).
- One Large bucket of range balls per day. (\$15 value)
- 15% discount off full-priced soft goods (shirts and shorts). This discount is not valid towards any sale item that is already discounted 15% or more.
- World Handicap Services for 2025.
- Discounted Green Fees for accompanied guests.
- Complimentary Enrollment in Troon Rewards program.

Terms and Conditions

- The Triple Crown program is an annual pass program that allows for frequent play at a discounted rate. As such, the Triple Crown Program is not a Membership Program in any way. The Triple Crown Pass does not provide any ownership or control over the Club in any manner. No additional rights, privileges, or benefits should be inferred or expected except for those expressly stated herein.
- As IRONHORSE Golf Club is a daily-fee course, there will be dates in which tournament groups will take up the course. In this regard, there will be dates where tee times will not be available to annual pass holders.
- Annual Passes are not transferable.
- Annual Passes are valid 3/1/25 through 2/28/26.
- Annual Passes can be paid in full at time of purchase.
- If desired, two payments can be made for the pass:
 - One-half due at the time of purchase.
 - Second half due no later than June 1st, 2025.

Note: Changing or providing inaccurate credit card information, disputing charges relating to the annual pass, or any other action taken which impedes the collection of annual pass payment will result in the immediate termination of the pass and suspension of access to any golf facilities, including the range, until any and all damages have been recouped.
- Annual Pass fees are non-refundable. In the event of a medical emergency or relocation out of the area, exceptions may be made by the GM and City of Leawood on a case-by-case basis.
- Acts of God or other developments out of the control of Troon Management or the City of Leawood will not constitute a pro-rated or full refund.
- To be eligible for the Annual Pass renewal window and pricing, a person must have maintained a pass for the 2024-25 program year.
- Current pass holders wishing to renew their pass for the 2025-2026 program year will have a protected window of time through February 14, 2025.
- Based on availability, remaining passes will be sold on a first-come, first-served basis.
- Beginning February 15, 2025, Leawood Residents who were not pass holders for the 2024 Program Year will have the first opportunity to submit applications. Leawood Residency will be verified via means other than a current Driver's License.
- Starting March 1, 2025, any remaining passes will be sold on a first-come, first-served basis.
- Dependent eligibility is limited to immediate family members, or a registered domestic partner, residing in the same home.
- To qualify as a Junior Dependent, a person must be no older than 18 years of age by the start of the program year, March 1, 2025.
- To qualify for the Senior Triple Crown pass, a person must be at least 60 years of age by the start of the program year, March 1, 2025.
- To qualify for the Intermediate Triple Crown pass, a person must be no older than 39 years of age by the start of the program year, March 1, 2025.
- All annual pass holders are required to register in the Golf Shop prior to teeing off.

- Five-some's are not allowed on the golf course at any time.
- Practice balls provided may not be accumulated in any way nor removed from the range. Additional practice balls must be purchased at normal rates.
- Daily receipts must be shown to the starter in order for staff to properly track rounds of golf.
- Senior Triple Crown passes are valid Monday – Friday excluding holidays. Weekend and holiday green fees will be \$70 before 12 PM and \$27 after 12 PM.
- Guests of Triple Crown pass holders receive an 18-hole discounted rate of \$60 Monday-Thursday, \$70 Friday-Sunday *only* when accompanied by a valid Triple Crown Pass Holder. Discount valid for up to three guests.
- Guest greens fee discounts do not apply to contracted group activity.
- Troon Rewards will be awarded for your Triple Crown Annual Pass. Any rounds earned through this program may only be used for yourself at *other* Troon Facilities.
- In accordance with State and Local Laws, outside alcohol may not be brought on, nor consumed on, the premise, including the parking lot. Any such items that are found will be confiscated and may result in the immediate termination of the annual pass.
- You represent that you are familiar with the operation and use of a golf cart and agree to return the golf cart immediately following the completion of play in the same condition as when received. You agree to pay for any damage to the golf cart which may occur while the golf cart is in your possession. Further, you agree to waive, on behalf of yourself and your heirs, any and all rights to assert a claim(s), suits, damages, or cause(s) of action against Ironhorse Golf Club, the City of Leawood, KS, and Troon Golf, LLC which you have arising from use of a cart on the premises. **By signing this application, you are accepting of our waiver language for yourself, and any others for whom you have paid.**
- Ironhorse Golf Club represents and warrants that it follows all applicable Federal, State, and Local Laws, Ordinances, and Executive Orders. As such, all patrons are expected to comply and follow such regulations. Any instance of willful and/or repeated disregard for such regulations, and/or other socially unacceptable behavior, may result in the immediate termination of the annual pass without refund of payment and permanent ban from the facility.
- Ironhorse Golf Club reserves the right to modify this program at any time without advanced notice.
- Ironhorse Golf Club reserves the right to discontinue the program at any time without advanced notice, but will honor the timeframe remaining on any outstanding Annual Passes.
- Ironhorse Golf Club reserves the right to terminate the annual pass for violation of the terms and conditions.
